

ORDINANCE NO. ____

AN ORDINANCE ALLOWING A SPECIAL USE TO ALLOW A DAYCARE CENTER IN A R-3 ZONE FOR CERTAIN REAL PROPERTY LOCATED AT 200 WEST 20th STREET IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, application was duly made by Beverly Hall, P.O. Box 1925, North Little Rock, Arkansas 72115, seeking a special use of land located at 200 West 20th Street to allow a daycare center in an R-3 zone, which application was duly considered and approved (6 affirmative votes, 3 absent) by the North Little Rock Planning Commission at a regularly scheduled meeting thereof, held on October 08, 2019.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1. That a special use is granted for a daycare center in an R-3 zone for the subject real property being more particularly described as:

Lot R, Block 24, City of North Little Rock, Pulaski County, Arkansas (See maps attached hereto collectively as Exhibit A.)

SECTION 2. That this special use shall be subject to the following conditions:

1. Hours of operation: 6:00 a.m. to 6:00 p.m., Monday - Friday.
2. On-site playgrounds to be directly accessed from the building.
3. Playground to have emergency exit away from the building.
4. Allow playground fence to be 4' chain link with 6' wood privacy fence along Maple Street and connecting to the building.
5. Existing out parcel playground to be used by 6 to 12 year olds and to be accompanied by staff at all times.
6. The playgrounds are only to be used during daylight hours.
7. Applicant shall meet all Federal, State, County, and City requirements and codes.
8. Business license to be issued after Planning Staff confirmation of requirements.
9. Playground to meet DHS and City of North Little Rock requirements for playground surface and equipment.
10. All daycare centers/home daycares shall perform a sex offender residence check through the North Little Rock Police Department according to their rules and procedures, to determine if a level 3 or level 4 registered sex offender resides within 2,000 feet of the proposed site for the daycare center/home daycare.
11. Applicant/owner understands that failure to comply with these conditions may result in loss of the Special Use and/or loss of Business License and/or removal of Electric Power Meter.

SECTION 3. That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.

SECTION 4. That the provisions of this Ordinance are hereby declared to be severable and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 5. It is hereby found and determined that the special use of the above-described lands as provided for herein is immediately necessary in order to insure the proper and orderly growth of this land and the proper and orderly growth of the City of North Little Rock, Arkansas, and being necessary for the immediate preservation of the public health, safety and welfare, THEREFORE, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect on the date set forth below.

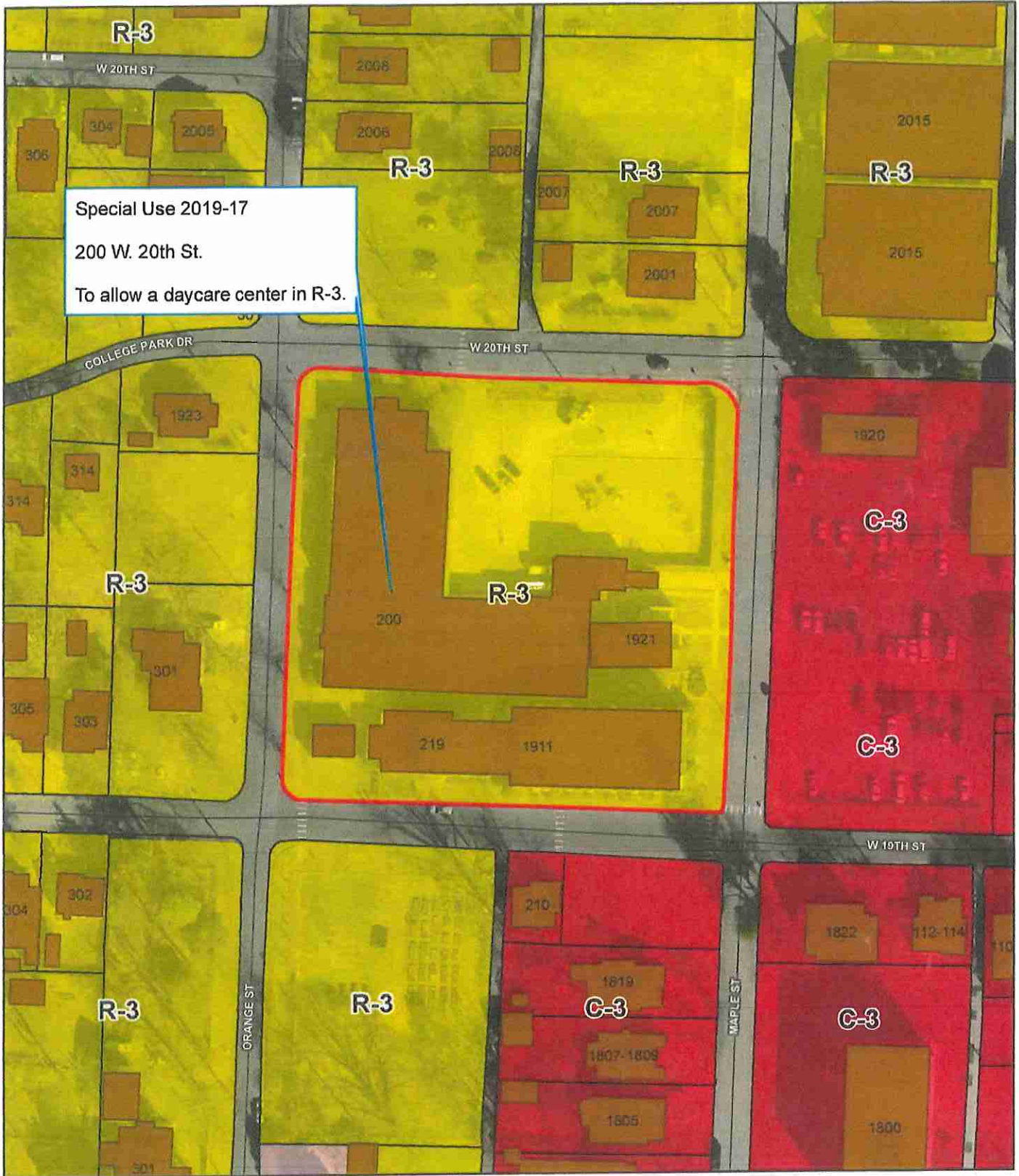

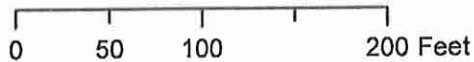

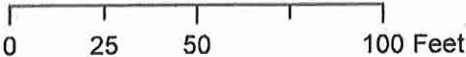
