**A RESOLUTION AUTHORIZING THE NORTH LITTLE ROCK POLICE DEPARTMENT TO DONATE CERTAIN USED EQUIPMENT TO THE CITY OF GOULD, ARKANSAS POLICE DEPARTMENT; AND FOR OTHER PURPOSES.**

WHEREAS, the North Little Rock Police Department (“NLRPD”) has certain items of equipment that have been replaced and are no longer being used by the department; and

WHEREAS, the NLRPD has received a request from the Police Department of the City of Gould, Arkansas, expressing a need for the used equipment (see Exhibit A attached hereto); and

WHEREAS, pursuant to Ark. Code Ann. §14-52-113 a municipal police department may exchange personal property with another municipal police department.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the North Little Rock Police Department is hereby authorized to donate the following used equipment to the City of Gould Police Department:

- A 2002 Ford Crown Victoria, VIN #2FAFP71W72X155964
- Two (2) Halogen Spotlights
- Two (2) Patriot Light Bars
- Four (4) Dual Talon Deck Lights
- Four (4) Single Talon Deck Lights
- Four (4) Three Way Power Supplies
- One (1) Radar

SECTION 2: That the donation of the equipment described in Section 1 above shall be made pursuant to the following conditions:

- (a) The City of Gould Police Department will acknowledge that the equipment is *used* and is beyond the recommended use time by the manufacturer.
- (b) The City of North Little Rock Police Department or any of its agents or officers do not offer any warranty on the used equipment, express or implied.
- (c) The City of Gould Police Department will retain ownership of the used equipment and will assume all liability for its use until such time as it is destroyed and made totally unusable.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval.

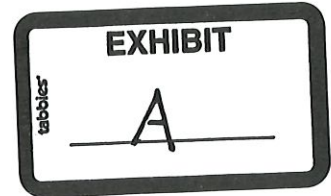
