## RESOLUTION NO.

A RESOLUTION AUTHORIZING PAYMENT OF ADDITIONAL FUNDS TO HYDCO, INC. FOR THE REPAIR OF THE LAMAN LIBRARY FOUNTAIN; APPROPRIATING FUNDS; AND FOR OTHER PURPOSES.

WHEREAS, pursuant to Ordinance No. 9020, adopted on June 25, 2018, the City of North Little Rock (the "City") waived bidding and appropriated funds in the amount of \$35,000.00 for the repair of the Laman Library fountain, with the funds appropriated from Special Appropriations (funded from the General Fund); and

WHEREAS, the actual costs have exceeded the previous estimates, due to more extensive repairs being required than initially thought necessary; and

WHEREAS, the revised cost for the repair of the fountain is now \$46,661.00 (see invoice from Hydco, Inc. attached hereto as Exhibit A), of which \$35,000.00 has already been paid (see check from the City attached hereto as Exhibit B); and

WHEREAS, funding for the additional cost of construction is available from unappropriated funds currently available in Special Appropriations from the General Fund; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That payment in the amount of \$11,661.00 to Hydco, Inc. for the additional cost of repairs to the Laman Library foundation is hereby authorized and approved.

SECTION 2: That the sum of Eleven Thousand Six Hundred and Sixty-One & 00/100 Dollars (\$11,661.00) is hereby appropriated from Special Appropriations from the General Fund.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval.


