# ORDINANCE NO. \_\_\_\_

AN ORDINANCE ESTABLISHING THE CITY OF NORTH LITTLE ROCK MUNICIPAL PROPERTY OWNERS' MULTIPURPOSE IMPROVEMENT DISTRICT NO. 38 (THE PORCHES AT ROCKWATER PROJECT); DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, there has been filed with the City Clerk of the City of North Little Rock, Arkansas, a petition purporting to be signed by the owners of all of the real property described within the petition ("Property"), praying that a municipal property owners' multipurpose improvement district be established for the purposes set forth herein, said Petition and Abstractor's Certificate of Property Ownership being attached hereto as Exhibits A and B respectively; and

WHEREAS, after due notice as required by law, the City Council of the City of North Little Rock, Arkansas (the "City Council") has heard all parties desired to be heard.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That owners of all of the real property described in the Petition signed the Petition, and there is hereby established a municipal property owners' multipurpose improvement district (the "District") within the Property, for the purposes of (a) constructing waterworks, sewers, and systems of gas pipelines, and (b) grading, draining, paving, curbing, and guttering street and laying sidewalks, together with facilities related to any of the foregoing within the District, and doing all things now or hereafter permitted under applicable law, including, without limitation, Ark. Code Ann. § 14-94-101 et seq., to be done and performed by municipal property owners' improvements districts. The District shall have the right to exercise the power of eminent domain in accordance with Arkansas state law in order to carry out its purposes.

SECTION 2: The District shall be known as North Little Rock Municipal Property Owners' Multipurpose Improvement District No. 38 (The Porches at Rockwater Project) of North Little Rock, Arkansas. Lisa Ferrell, Joshua Miller and Jim Jackson, all whose names appear in the petition, are hereby named as Commissioners who shall constitute the Board of the District.

SECTION 3: Any ordinances or parts of ordinances that are in conflict herewith are hereby repealed to the extent they conflict with this ordinance.

SECTION 4: That the provisions of this Ordinance are hereby declared to be severable, and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 5: It has been found, and it is hereby declared, by the City Council that there is an immediate need within the City of North Little Rock, Arkansas, for additional infrastructure within the City and that the passage of this Ordinance will facilitate construction of additional infrasctucture within the City; THEREFORE, an emergency is hereby declared to exist, and this Ordinance, being necessary for the preservation of the public health, safety and welfare, shall be in full force and effect from and after its passage and approval.

PETITION TO FORM NORTH LITTLE ROCK MUNICIPAL PROPERTY OWNERS' MULTIPURPOSE IMPROVEMENT DISTRICT NO. 38 (THE PORCHES AT ROCKWATER PROJECT)

For its Petition to form North Little Rock Municipal Property Owners' Multipurpose Improvement District No. 3, the undersigned petitioner states:

- 1.
