Dear Mayor Smith;

November 2017 officer Williams noticed vacant, structurally unsound structure. Owners of record were mailed notice of public nuisance and a request for an interior inspection. This structure has been vacant since April 2014 according to North Little Rock utility department.

November 30th 2017 Officer Williams conducted an interior inspection with the owner. The inspection revealed missing and damaged ceilings, damaged electrical, plumbing, walls and holes in the floors throughout the structure.

Notice of City Council scheduled for February 26th, 2018 hearing date was mailed by certified and regular mail and posted to the premises. Notice of hearing was also ran in local newspaper.

January 2018 Ms. Stovall called the office to advise she was giving the house to her nephew Mr. Reggie McGee. The city council date was canceled due to some work being done on the structure and a new owner. Mr. McGee contacted the office advising he was the owner but had not recorded the paper work at the court house. Mr. McGee requested a list of demolition contractors.

August 2018 there had been no further work done to the structure nor had there been any Demo permits pulled for the structure. Mr. McGee was issued a citation for court. As of this date the structure is in the same condition.

Notice of City Council scheduled for March 25th 2019 hearing date was mailed by certified and regular mail and posted to the premises. Notice of hearing was also ran in local newspaper.

The structure is considered to be unfit for human habitation and also a public nuisance, it is the recommendation of the North Little Rock Code Enforcement Department that this structure be considered for condemnation.
