## ORDINANCE NO.

AN ORDINANCE GRANTING A WAIVER OF THE SIDEWALK REQUIREMENT OF SECTION 12.21 OF THE ZONING ORDINANCE FOR A CONNECTING STREET ON CERTAIN REAL PROPERTY LOCATED AT THE NORTH SIDE OF PHASE 25, COUNTRY CLUB OF ARKANSAS TO WHITE OAK CROSSING IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, a request has been made by Holloway Engineering, 200 Casey Drive, Maumelle, Arkansas 72113, to waive certain Zoning Ordinance requirements for a connecting street located at the north side of Phase 25, Country Club of Arkansas to White Oak Crossing in the City of North Little Rock, Arkansas (See letter from Mark Redder of Holloway Engineering dated April 9, 2019 attached hereto as Exhibit A and maps attached hereto as Exhibit B); and

WHEREAS, the applicant seeks waiver of the sidewalk requirement of Section 12.21 of the Zoning Code; and

WHEREAS, the applicant appeared before the North Little Rock Planning Commission at a regularly scheduled meeting held on April 9, 2019, and submitted his request of waiver to the Commission; and

WHEREAS, the applicant's sidewalk waiver request was reviewed and denied (6 affirmative votes to require sidewalks; 3 absent) by the Planning Commission at its April 9, 2019 meeting; and

WHEREAS, the applicant is appealing the decision to the City Council and is seeking approval to waive the requirements.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the following waiver of the Zoning Code is hereby granted for property located at the north side of Phase 25, Country Club of Arkansas to White Oak Crossing in the City of North Little Rock as depicted in Exhibit B attached hereto and incorporated herein by reference:

- 1. Waiver of required sidewalk requirements Section 12.21
- SECTION 2: That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.
- SECTION 3: That the provisions of this Ordinance are hereby declared to be severable and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 4: That it is hereby found and determined that the requirement to build a sidewalk at the connecting street at the above mentioned property is to be waived, and the immediate passage of this Ordinance is necessary in order to insure the proper and orderly growth and development of this land and the City of North Little Rock, Arkansas, and being necessary for the immediate preservation of the public health, safety and welfare, THEREFORE, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect from and after its passage and approval.

Dear Mayor Smith and City Council Members,

We are asking for a variance of the sidewalk requirement from the north side of Phase 25, Country Club of Arkansas to White Oak Crossing. We are asking for this wavier due to the fact that this is a connecting street from White Oak Crossing to our subdivision. Typically, a subdivision such as this is not burdened with the hardship of constructing a new connector street. The property to the east of this connector street will be a private residential subdivision and will not have access to this connector street. There will be adequate shoulder width to allow pedestrian traffic to reach White Oak Crossing which also has asphalt shoulders.


We are proposing that the connector street be built with no curb and gutter but constructed with wide asphalt shoulders. WHITE DAK CROSSING


AREA OF SIDEWALK WAIVER -
