RESOLUTION NO. _____

AN RESOLUTION AUTHORIZING DISPOSAL IN LANDFILL OF CERTAIN CITY-OWNED ITEMS THAT HAVE BEEN RENDERED WORTHLESS BY DAMAGE OR PROLONGED USE, OR THAT HAVE ONLY RESIDUAL VALUE AND HAVE BEEN THROUGH PUBLIC AUCTION AND NOT SOLD; AND FOR OTHER PURPOSES.

WHEREAS, the City of North Little Rock ("the City") owns certain items of personal property that have been rendered worthless by damage or prolonged use; and

WHEREAS, the City owns certain items of personal property that have only residual value that have been offered for sale through public auction through GovDeals and have not sold; and

WHEREAS, pursuant to Ark. Code Ann. § 14-54-302(e)(2), personal property that has been rendered worthless by damage or prolonged use, and property that has only residual value and has been through public auction and not sold, may be disposed of in a landfill if authorized by the Mayor, or his representative, and the City Council; and

WHEREAS, it is in the City's best interest to dispose of these items of property.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the items listed on Exhibit A are declared to have been rendered worthless by damage or prolonged use, or to have only residual value and have been offered for sale through public auction and not sold, and the Director of Commerce is directed to dispose of the items listed on Exhibit A in the landfill used by the City.

SECTION 2: That this Resolution shall be in full force and effect from and after its passage and approval.
