## RESOLUTION NO.

A RESOLUTION AUTHORIZING TRANSFER OF PROCEEDS OF SALE OF CERTAIN VACANT PROPERTY GENERALLY LOCATED ALONG THE NORTH BANK OF THE ARKANSAS RIVER BETWEEN THE RIVER AND ARKANSAS STATE HIGHWAY 165 TO NORTH LITTLE ROCK WASTEWATER UTILITY; AND FOR OTHER PURPOSES.

WHEREAS, on March 26, 2018, the North Little Rock City Council ("City Council") passed Resolution 9393, authorizing the sale of property consisting of an estimated 40+ acres and generally located on the north bank of the Arkansas River south of Arkansas State Highway 165 to Blue Rock Sportsman's Club, Inc., for fair market value of \$2,387.50 per acre; and

WHEREAS, the sale of the property closed on April 12, 2018, resulting in net proceeds in the amount of \$93,924.46 paid to the City of North Little Rock ("City") (See ALTA Settlement Statement attached hereto as Exhibit A); and

WHEREAS, Resolution 9393 provided that the proceeds from the sale are to be used exclusively for the use of the North Little Rock Wastewater Treatment Utility ("North Little Rock Wastewater")

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the That the Finance Department is hereby directed to transfer the net proceeds from the sale of the property in the amount of \$93,924.42 to North Little Rock Wastewater.

SECTION 2: That this Resolution shall be in full force and effect from and after its passage and approval.
