Greetings,

This letter is to call your attention to the fact that the Pulaski County Voter Registration Office has determined that Thirty (30) or more of the original electors are not registered voters. This is very unfortunate because for the particular statute to create and establish an "Urban Service District" requires a certain number of petitions, 25% of the voters in the district. As determined by the Pulaski County Voter Registration List and Attorney Bob Hardin, the number of total eligible residence total 393.

If the original petitions totaled approximately 118 signatures; and the exact number has been difficult to determine due to the duplicate signatures. There are approximately 6 to 14 duplicates and that is dependent on whether you count the petitions with more than one signature. Therefore, if that particular petitioner has been deemed ineligible, and they are also a duplicate, this causes much confusion on the total. So if the total equals 118, and we have been notified that 30 Stonelinks residents that signed the initial petition are not eligible, and then 4 of those eligible are duplicates, that leaves the final initial petitioners to equal 84.


Therefore, I MUST CONTEST the signatures that have been submitted by Attorney Bob Hardin and the filing of the Original Petition to ***Establish Stone Links Drive Urban Service District NO.2 of North Little Rock, Arkansas, 72117*** and all of the effects and other purposes.

- The unregistered petitioner's signatures are not valid
- The minimum threshold for establishing or forming an Urban Service District has not been met
- The many duplicate signatures on the original petition

If the City Clerk needs an official copy of the Pulaski County Clerks findings, please let me know and I will have Rebeca A. Lynn, Voter Registration Supervisor send to the courts for your review, if required.

I do pray for your assistance in the most urgent matter.
