## RESOLUTION NO.

A RESOLUTION AMENDING THE CITY OF NORTH LITTLE ROCK 2017 BUDGET FOR RECEIPT AND EXPENDITURE OF FUNDS FOR THE HERITAGE PARK CIRCLE URBAN SERVICE DISTRICT NO. 1 AND STONE LINKS DRIVE URBAN SERVICE DISTRICT NO. 2; AND FOR OTHER PURPOSES.

WHEREAS, Heritage Park Circle Urban Service District No. 1 was established by Ordinance No. 8237 (adopted 02/22/10), thereafter amended on March 10, 2010 pursuant to Ordinance No. 8240; and

WHEREAS, Stone Links Drive Urban Service District No. 2 was established pursuant to Ordinance No. 8891 adopted March 13, 2017; and

WHEREAS, pursuant to Ark. Code Ann. § 14-95-401(b), the budget of each urban service district in the City of North Little Rock (the "City") ". . . shall be appropriated as other funds of the City; and

WHEREAS, the City has received funds collected by Central Arkansas Water ("CAW) for the benefit of the Heritage Park Circle Urban Service District No. 1 ("Heritage Park USD No. 1") and Stone Links Drive Urban Service District No. 2 ("Stone Links USD No. 2"), which funds need to be included in and disbursed pursuant to the City's annual budget; and

WHEREAS, North Little Rock City Council has found and determined that it is necessary and desirable to amend the 2017 Budget (pursuant to Resolution No. 9108 adopted December 12 2016) to include additional revenues and expenses for the Heritage Park USD No. 1 and Stone Links USD No. 2. .

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the 2017 Budget for the City of North Little Rock should be, and is hereby, amended to include revenues and expenditures for the Heritage Park USD No. 1 and Stone Links USD No. 2 as follows:
