AN ORDINANCE APPROVING A REQUEST TO WAIVE CERTAIN REQUIREMENTS OF THE MASTER STREET PLAN FOR ACCESS CRITERIA FOR PROPERTY LOCATED AT 12209 HIGHWAY 70 IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, application to waive certain requirements of the Master Street Plan was duly made by Richardson Engineering, PLLC, P. O. Box 192, Benton, Arkansas 72018 for property located at 12209 Highway 70, in the City of North Little Rock, Arkansas, more particularly described as follows:

WHERAS, said application was duly considered and approved by the North Little Rock Planning Commission (7 affirmative votes, 2 absent) at a regularly scheduled meeting thereof held on February 13, 2018.

WHEREAS, a request has been made seeking a waiver of the North Little Rock Master Street Plan requirements for access criteria described as follows:

## 8.2.1 Access Criteria.

a. A minimum spacing of 200 ft. for future connections (e.g. driveways, etc.) to the Roadway.

## Access Criteria.

(a) Provide a distance between driveways of 95 feet.
