AN ORDINANCE CALLING A SPECIAL ELECTION IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS, ON THE QUESTION OF LEVYING A ONE PERCENT (1%) LOCAL SALES AND USE TAX WITHIN THE CITY OF NORTH LITTLE ROCK, ARKANSAS, ONE-HALF OF WHICH SHALL ONLY BE LEVIED UNTIL DECEMBER 31, 2022 AND SHALL ONLY BE USED TO ACQUIRE, CONSTRUCT, REPAIR, AND/OR IMPROVE STREETS, DRAINAGE STRUCTURES; AND FACILITIES FOR THE POLICE DEPARTMENT, THE FIRE DEPARTMENT, AND THE DISTRICT COURTS, AND ONE-HALF OF WHICH SHALL NOT BE LIMITED IN DURATION OR USE; PRESCRIBING OTHER MATTERS PERTAINING THERETO; AND DECLARING AN EMERGENCY.

	WHEREAS, the City Counc	il of the City of No	rth Little Rock,	Arkansas (the "Ci	ty"), has

WHEREAS, the purpose of this Ordinance is to call a special election on the question of the levy of the Sales and Use Tax.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1. That there be, and there is hereby called, a special election to be held on **August 8, 2017**, at which election there shall be submitted to the electors of the City the question of the levy of the Sales and Use Tax.

SECTION 2. That the question of levying the Sales and Use Tax shall be placed on the ballot for the election in substantially the following form:

Vote on measure by placing an "X" in the square opposite the measure either for or against:

FOR adoption of a one percent (1%) local sales and use tax within the City of North Little Rock, Arkansas, one-half of which shall only be levied until December 31, 2022 and shall only be used to acquire, construct, repair, equip, and/or improve streets, drainage structures; and facilities for the Police Department, Fire Department, and the District Courts, and one-half of which shall not be limited in duration or use

AGAINST adoption of a one percent (1%) local sales and use tax within the City of North Little Rock, Arkansas, one-half of which shall only be levied until December 31, 2022 and shall only be used to acquire, construct, repair, equip, and/or improve streets, drainage structures; and facilities for the Police Department, Fire Department, and the District Courts, and one-half of which shall not be limited in duration or use

SECTION 3. That the election shall be held and conducted and the vote canvassed and the results declared under the law and in the manner now provided for municipal elections unless otherwise provided in Title 26, Chapter 75, Subchapter 3 of the Arkansas Code of 1987 Annotated (the "Authorizing Legislation") and only qualified voters of the City shall have the right to vote at the election.

SECTION 4. That the results of the election shall be proclaimed by the Mayor, and his Proclamation shall be published one time in a newspaper having a general circulation in the City, which Proclamation shall advise that the results as proclaimed shall be conclusive unless attacked in the courts within thirty (30) days after the date of publication.

SECTION 5. That a copy of this Ordinance shall be given to the Pulaski County Board of Election Commissioners so that the necessary election officials and supplies may be provided. A certified copy of this Ordinance shall also be provided to the Commissioner of Revenues of the State of Arkansas as soon as practical.

SECTION 6. That the Mayor and City Clerk, for and on behalf of the City, be, and they are hereby authorized and directed to do any and all things necessary to call and hold the special election as herein provided and, if the levy of the Sales and Use Tax is approved by the electors, to cause the current Sales and Use Tax to be designated as provided above, and to perform all acts of whatever nature necessary to carry out the authority conferred by this Ordinance.

SECTION 7. That all ordinances and parts thereof in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 8. It is hereby ascertained and declared that the current economic climate demands additional funding for job growth and development in the City, as well as improvement of the City's capital resources, such that there is a great need for a stable source of revenue in order to promote and protect the health, safety and welfare of the City and its inhabitants, it is, therefore, declared that an emergency exists and this Ordinance being necessary for the immediate preservation of public peace, health and safety shall be in force and take effect immediately from and after its passage.
