ORDINANCE NO. ____

AN ORDINANCE GRANTING A WAIVER OF SECTION 14.115 OF THE ZONING ORDINANCE TO ALLOW AN ELECTRONIC CHANGEABLE COPY SIGN ON CERTAIN REAL PROPERTY LOCATED AT 11601 KINARD ROAD IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, a request has been made Rodney Pugh of Truckomat Corporation, P.O. Box 640, Walcott, Iowa 52773, to allow an electronic changeable copy message LED sign in a Highway 391 Overlay District to be located at 11601 Kindard Road (see letters from Rodney Pugh of Truckomat Corporation attached hereto as Exhibit A); and

WHEREAS, on July 23, 2018, the North Little Rock City Council ("City Council") enacted Ordinance No. 9033, which amended Ordinance 7697 (the "Zoning Ordinance") by adding Section 14.115 to the Zoning Ordinance, creating the Highway 391 Sign Overlay District; and

WHEREAS, Section 14.115 of the Zoning Ordinance permits electronic changeable copy signs within the Highway 391 Sign Overlay District; and

WHEREAS, the applicant seeks a waiver of the requirements pursuant to Section 14.115(D)(b) of the Zoning Ordinance which provides that signs shall be limited to a maximum of eighteen (18) feet in height; and

WHEREAS, the applicant seeks a waiver of the requirements pursuant to Section 14.115(D)(c) of the Zoning Ordinance which provides that signs shall be limited to a maximum of eighty-four (84) square feet; and

WHEREAS, a legal advertisement of notice of a public hearing to be held June 10, 2019 at 6:00 p.m. has been placed in the newspaper; and

WHEREAS, the request has not been reviewed by the Planning Commission, and applicant is seeking approval from the North Little Rock City Council.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the current sign is hereby permitted on real property located 11601 Kinard Road, being more particularly described as follows:

Lot 1, Truckomat Addition, North Little Rock, Pulaski County, Arkansas, (see map attached hereto as Exhibit B).

SECTION 2: That a waiver of the maximum sign height requirements of Section 14.115(D)(b) and sign square foot requirements Section 14.115(D)(c) of the Zoning Ordinance is

hereby granted for 11601 Kinard Road, North Little Rock, Pulaski County, Arkansas, to allow for a 501 square foot, 42 foot, 5 inch-tall ground mounted sign that includes a 5 foot, 9 inch by 12 foot cabinet electronic changeable copy sign (see images attached hereto as Exhibit C).

SECTION 3: That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.

SECTION 4: That the provisions of this Ordinance are hereby declared to be severable and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 5: It is hereby found and determined that the herein-described sign on 11601 Kinard Road will not detract from the aesthetic appearance of the neighborhood or interfere with other development in the area, and that the immediate passage of this Ordinance is necessary in order to insure the proper and orderly growth and development of this land and the City of North Little Rock, Arkansas, and being necessary for the immediate preservation of the public health, safety and welfare, THEREFORE, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect from and after its passage and approval.


