To NLR Councilmen, Mayor Smith, and officials,

I, Evelyn Creal, have lived in the Meadow Park Neighborhood over 30 years. There have been many complaints at our neighborhood meetings about the nighttime noise generated by the Scrap Metal Co. on Hwy 70 N.L.R., and we have reported this to our aldermen. We were informed that the company's hours of operation are to end at 8pm. This time frame has not been honored and the noise goes on late into the night. I do not live as close to the Scrap Metal business as some resident's but the noise disturbs me. Approximately 6 wks ago, after 11pm, the noise was so loud, it sounded as if someone was crashing cars in my front yard.

The Scrap Metal Company is located on the south side of our neighborhood, and approximately 60-70 feet from the nearest residents that reside in the trailer park. The Metal Company yard and the trailer park are separated by a railroad track. The Trailer park residents that I spoke with were ALL upset with the late night noise, many reported the noise goes on at 3 and 4 am and greatly disturbs them at night. Some of the residents said they have reported the late night noise on many occasions with no results.

We as a neighborhood do not oppose the business and we realize that recycling is very important; however we do oppose the afterhour's noise pollution that is disturbing the rest and peace of the residents of Meadow Park.

We are requesting that the late night noise restriction be enforced.
