RE: Ballot and polling places for Sales Tax Election

The North Little Rock City Council recently adopted Ordinance No. 8913 calling for a special election on August 8, 2017 to consider a local sales tax. My office has been working in cooperation with the Pulaski County Election Commission to establish the ballot form, which is attached to this communication for your reference. Rather than restating the title twice, this ballot states the title a single time and asks the voter to simply choose FOR or AGAINST, in compliance with Section 2 of Ordinance No. 8913.

I have also attached a list of the tentative polling places for your reference. I anticipate that the Pulaski County Election Commission will finalize this list at their next meeting. Please let me know if you would like me to request any changes to this list. Also, Laman Library will likely be used for early voting, as it has in other elections.

One Percent (1%) Local Sales and Use Tax

Adoption of a one percent (1%) local sales and use tax within the City of North Little Rock, Arkansas, one-half of which shall only be levied until December 31, 2022 and shall only be used to acquire, construct, repair, equip, and/or improve streets, drainage structures; and facilities for the Police Department, Fire Department, and the District Courts, and one-half of which shall not be limited in duration or use.
