A RESOLUTION AMENDING THE 2011-2015 CONSOLIDATED PLAN, THE 2015 ANNUAL ACTION PLAN, THE 2016-2020 CONSOLIDATED PLAN AND THE 2016 ANNUAL ACTION PLAN OF THE CITY OF NORTH LITTLE ROCK IN REGARD TO THE HOME INVESTMENT PARTNERSHIP (HOME) PROGRAM AND COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM; AND FOR OTHER PURPOSES.

WHEREAS, the City of North Little Rock, Arkansas (the "City") submitted the following plans to the Department of Housing and Urban Development:

- (1) 2011-2015 Consolidated Plan on January 17, 2011;
- (2) 2015 Annual Action Plan on March 10, 2015;
- (3) 2016-2020 Consolidated Plan and 2016 Annual Action Plan on April 14, 2016; and

WHEREAS, the City is amending its 2011-2015 Consolidated Plan to reallocate funds from the discontinued HOME Rehabilitation program project to the HOME Community Housing Development Organization (CHDO) program for new construction of affordable housing for low income homebuyers; and

WHEREAS, the City is amending its 2015 Annual Action Plan to transfer \$61,905.48 from the HOME Single Family Rehabilitation project to the HOME Community Housing Development Organization (CHDO) project for new construction of affordable housing for low income homebuyers; and

WHEREAS, the City is amending its 2016-2020 Consolidated Plan to reallocate funds from the discontinued HOME Rehabilitation program project to the HOME CHDO program for new construction of affordable housing for low income homebuyers; and to reallocate estimated 2017-2020 funding for the CDBG Housing Rehabilitation program to public infrastructure/street and drainage improvement projects to benefit residents in low to moderate income areas of the City; and

WHEREAS, the City of North Little Rock is amending its 2016 Annual Action Plan to transfer \$83,579.20 from the HOME Homeowner Rehabilitation project to the HOME CHDO Homebuyer New Construction project for low income homebuyers.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the 2011-2015 Consolidated Plan is amended pursuant to Exhibit "A" attached hereto and incorporated herein by reference.

SECTION 2: That the 2015 Annual Action Plan is amended pursuant to Exhibit "B" attached hereto and incorporated herein by reference.

SECTION 3: That \$61,905.48 from the HOME Single Family Rehabilitation Project will be reallocated to the HOME Community Housing Development Organization (CHDO) project as outlined in Exhibit "B" attached hereto.

SECTION 4: That the 2016-2020 Consolidated Plan and 2016 Annual Action Plan are amended pursuant to Exhibit "C" attached hereto and incorporated herein by reference.

SECTION 5: That \$83,579.20 from the HOME Single Family Rehabilitation Project will be reallocated to the to the HOME Community Housing Development Organization (CHDO) project as outlined in Exhibit "C" attached hereto.


SECTION 6: That this Resolution shall be in full force and effect from and after its passage and approval.


