## ORDINANCE NO. \_\_\_\_

AN ORDINANCE ALLOWING A SPECIAL USE TO ALLOW A TATTOO PARLOR IN A C-6 ZONE FOR CERTAIN REAL PROPERTY LOCATED AT 112 MAIN STREET IN THE CITY OF NORTH LITTLE ROCK, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, application was duly made Scott Diffee, 4603 East Broadway Street, North Little Rock, Arkansas 72114, seeking a special use of land located at 112 Main Street to allow a tattoo parlor in a C-6 zone, which application was duly considered and approved (7 affirmative votes, 2 absent) by the North Little Rock Planning Commission at a regularly scheduled meeting thereof, held on July 09, 2019.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1. That a special use is granted for a tattoo parlor in a C-6 zone for the subject real property being more particularly described as:

Lot 4, Block 11, Argenta Addition, City of North Little Rock, Pulaski County, Arkansas (See maps attached hereto collectively as Exhibit A.)

SECTION 2. That this special use shall be subject to the following conditions:

- 1. Hours of operation: Tuesday Thursday, 2:00 p.m. to 10:00 p.m.; Friday Saturday, 2:00 p.m. to Midnight.
- 2. Meet the requirements of the Arkansas Department of Health for Body Art Establishments.
- 3. Any structures located on the lot shall meet all applicable Federal, State, County, and City requirements and codes.
- 4. Business license to be issued after Planning Staff confirmation of requirements.
- 5. Business license holder understands that failure to comply with these conditions may result in loss of the Special Use and/or loss of Business License and/or removal of Electric Power Meter.

SECTION 3. That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.

SECTION 4. That the provisions of this Ordinance are hereby declared to be severable and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 5. It is hereby found and determined that the special use of the above-described lands as provided for herein is immediately necessary in order to insure the proper and orderly growth of this land and the proper and orderly growth of the City of North Little Rock, Arkansas, and being necessary for the immediate preservation of the public health, safety and welfare, THEREFORE, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect on the date set forth below.




