A RESOLUTION APPROVING ACCEPTANCE BY THE NORTH LITTLE ROCK AIRPORT COMMISSION OF A GRANT FROM THE ARKANSAS DEPARTMENT OF AERONAUTICS FOR THE SEALING OF TAXIWAY JOINTS AND CRACKS IN THE HANGAR AREA; AND FOR OTHER PURPOSES.

WHEREAS, the Arkansas Aeronautics Commission has approved a 80-20% matching grant (Grant No. 3706-18) for the North Little Rock Municipal Airport (see Exhibit "A" attached hereto) for the sealing of taxiway joints and cracks in the hangar area; and

WHEREAS, total cost for the project is \$13,705.00 which will be paid as follows: Grant No. 3706-18 proceeds in the amount of \$10,964.00 (80% of the project cost), and local matching share in the amount of \$2,741.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the City Council approves acceptance by the North Little Rock Airport Commission of Grant No. 3706-18 from the Arkansas Department of Aeronautics in the amount of \$10,964, representing 80% of the costs for sealing the taxiway joints and cracks in the hangar area at the North Little Rock Municipal Airport.

SECTION 2: That the amount of \$2,741.00, representing 20% of the total project cost, shall be paid from funds previously appropriated to the Airport Commission.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval.


During the June 20, 2018 meeting of the Arkansas Aeronautics Commission, an 80-20% Grant Request was approved for North Little Rock Municipal Airport. The request approved provides funding in the amount of \$10,964.00 to seal taxiway joints and to seal cracks in the hangar area.

This grant has been assigned as Grant #3706-18 for identification purposes. When corresponding with our office regarding this project, please be sure to use this number.
