A RESOLUTION AMENDING RESOLUTION NO. 9331 (2018 BUDGET) TO AMEND THE FY18 BUDGET FOR A 2.2% PAY INCREASE TO FULL-TIME, NON-UNIFORMED, SALARIED AND CLASSIFIED EMPLOYEES (EXCLUDING UNIFORMED POLICE PERSONNEL), ALL FIRE PERSONNEL, POLICE CHIEF, ELECTED OFFICIALS AND CITY COUNCIL MEMBERS OF THE CITY OF NORTH LITTLE ROCK; AND FOR OTHER PURPOSES.

WHEREAS, through its adoption of Resolution No. 9331 on December 11, 2017, the North Little Rock City Council approved the budget for the City of North Little Rock, Arkansas (the "City") for the fiscal year 2018; and

WHEREAS, the North Little Rock City Council wishes to amend the budget to provide a 2.2% pay increase, effective August 11, 2018, to full-time, non-uniformed salaried and classified employees (excluding Uniformed Police Personnel), all Fire Personnel, Police Chief, Elected Officials, and City Council Members of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the 2018 Budget for the fiscal year 2018 is hereby amended as set out in Exhibit A, which is attached hereto and incorporated herein by reference, to provide a 2.2% pay increase, effective August 11, 2018, to full-time, non-uniformed, salaried and classified employees (excluding Uniformed Police Personnel), all Fire Personnel, Police Chief, Elected Officials and City Council Members of the City of North Little Rock, Arkansas.

SECTION 2: That the funds for the pay increases are hereby appropriated from the specific funds listed in Exhibit A.

SECTION 3: That all resolutions or parts of resolutions in conflict herewith are repealed to the extent of the conflict.

SECTION 4: That this Resolution shall be in full force and effect from and after its passage and approval.
