

ORDINANCE NO. _____

AN ORDINANCE AMENDING THE 2017 QUOTA ORDINANCE (ORDINANCE NO. 8871) FOR THE NORTH LITTLE ROCK CITY CLERK'S OFFICE AND CODE ENFORCEMENT DEPARTMENT; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, the City Council is responsible for establishing the number of employees in each department, and on December 27, 2016, adopted Ordinance No. 8871 establishing job classifications and numbers of employees for each department of the City of North Little Rock for 2017 (amended by Ordinance No. 8886 adopted on February 13, 2017 and Ordinance No. 8892 adopted on March 13, 2017); and

WHEREAS, it has been determined by the City Council that it is necessary from time to time to amend such ordinance to add or delete positions, to correct errors, reorganize departments, reclassify positions, re-title positions, and for other purposes, to increase the efficient operation of the City of North Little Rock; and

WHEREAS, the Code Enforcement Department has one position which needs to be moved to the City Clerk's Office; and

WHEREAS, there will not be an increase in the overall total number of positions in the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That Section 4 of Ordinance No. 8871, as amended by Ordinance No. 8886 and Ordinance 8892, is hereby amended as follows:

SECTION 4: That the City Clerk's Office shall consist of one (1) elected official and ~~three (3)~~ four (4) full-time employees as follows:

City Clerk-Treasurer (Elected), NEG – 1
Assistant to City Clerk -Treasurer, NEG - 1
Deputy City Clerk/Revenue Officer, Senior, NEG – 1
Deputy City Clerk/Revenue Officer, NEG – 1
Code Enforcement Officer/Licensing, NEG - 1

SECTION 2: That Section 5 of Ordinance No. 8871, as amended by Ordinance No. 8886 and Ordinance 8892, is hereby amended as follows:

SECTION 5: That the Code Enforcement Department shall consist of ~~fourteen (14)~~ thirteen (13) full-time employees as follows:

Director, NEG - 1
Code Enforcement Assistant, F06A - 1
Health Code Enforcement Officer, F09 - 1
Code Enforcement Officer, F07 - ~~8~~ 7
Code Officer Supervisor, F09A - 1
Helper, P06 - 2

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.

SECTION 4: That the provisions of this ordinance are hereby declared to be severable and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 5: That the City Council has determined that the interests of the City and City employees can best be served by the adoption of this ordinance; THEREFORE, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect from and after its passage and approval.
