A RESOLUTION AUTHORIZING ACCEPTANCE OF A SETTLEMENT OFFER FROM RIVER CITY MINISTRIES TO FOREGO A LIEN BEING PLACED BY THE CITY OF NORTH LITTLE ROCK AGAINST CERTAIN PROPERTY CURRENTLY OWNED BY VONDA BAILEY AND BEING LOCATED AT 1118 EAST WASHINGTON AVENUE; AND FOR OTHER PURPOSES.

WHEREAS, on March 27, 2017, following a public hearing and pursuant to Resolution No. 9185, the City of North Little Rock ("the City") declared property owned by Mr. Vonda V. Bailey and located at 1118 East Washington Avenue to be a nuisance and condemned it; and

WHEREAS, thereafter on or about June 22, 2017, the City abated the nuisance at a cost of \$8,337.00 and requested that reimbursement be made by Mr. Bailey on or before July 24, 2017 in order to avoid a lien being filed against the subject property by the City (see Exhibit "A" attached hereto); and

WHEREAS, the City has been advised by the attorney for River City Ministries ("River City") that discussions and negotiations have occurred with Mr. Bailey regarding his donation of the subject property to River City which included demolition of the structure on the property (see Exhibit "B" attached hereto); and

WHEREAS, River City, a non-profit organization which provides a great service to homeless and disadvantages persons in the City, had previously obtained a quote for demolition of the structure on the subject property in the amount of \$3,500.00 and has offered to pay that sum for the City to forego placing its lien thereon (see Exhibit "C" attached hereto); and

WHEREAS, in consideration of services provided by River City, it is in the best interests of the City and its residents that the settlement offer in the amount of \$3,500.00 be accepted, contingent upon the subject property being donated by Mr. Bailey to River City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the offer of River City Ministries in the amount of \$3,500.00 to forego the City placing a lien against property located at 1118 East Washington Avenue, North Little Rock, Arkansas, contingent upon transfer of title from the current property owner, Vonda V. Bailey, to River City Ministries, is hereby approved and accepted, said property being more specifically described as follows:

Lot 1, Block 1, Loomis Subdivision in the City of North Little Rock, Pulaski County, Arkansas. (Parcel No. 33N0050000200)



Re: Vonda Bailey Property and River City Ministry

Dear Jason:

I am writing on behalf of my client River City Ministries ("River City"). River City has been in discussions with Mr. Vonda Bailey regarding his donation and transfer of a number of lots to River City Ministry. The lots are located adjacent to the River City's office on Washington Street in North Little Rock. Part of the negotiations involved River City taking responsibility to tear down a structure on the lot located at 1118 E. Washington Ave. The legal description of the property is Lot 1, Block 1, Loomis Addition, Pulaski County, Arkansas. Mr. Bailey and River City were aware that the City of North Little Rock (the "City") had notified Mr. Bailey that if he did not remove the structure, the City would remove it. However, Mr. Bailey and River City had also notified the City of the intent of the parties to transfer the property to River City and River City would assume responsibility to remove the structure.

River City had obtained a quote from Ken Rowe with All Season Contractors in the amount of \$3,500.00 to demolish the structure and River City had full intentions of employing the company to remove the structure upon title passing to River City. A number of factors have delayed the transfer of the property, and on approximately June 20, 2017, the City razed the structure without providing Mr. Bailey or River City with notice of the City's immediate intent. Subsequently, Mr. Bailey received a bill from the City in the amount of \$8,337.00 for the services of removing the structure.

We are writing today to ask to the City to consider the offer of \$3,500.00 to settle Mr. Bailey's bill with the City and prevent a lien from being placed on the property. We have enclosed documentation received from the City as well as the quote that River City solicited to have the structure removed.
