**A RESOLUTION AUTHORIZING THE MAYOR AND THE CITY CLERK TO AMEND ALL AGREEMENTS BETWEEN THE CITY OF NORTH LITTLE ROCK, ARKANSAS AND MARLAR ENGINEERING COMPANY, INC. TO REFLECT THE ASSIGNMENT OF MARLAR ENGINEERING COMPANY, INC. TO HALFF ASSOCIATES INC., WHICH WILL NOW BE KNOWN AS HALFF ASSOCIATES INC. d/b/a/ HALFF + MARLAR; AND FOR OTHER PURPOSES.**

WHEREAS, Marlar Engineering Company, Inc. currently has several agreements with the City of North Little Rock for professional engineering services; and

WHEREAS, Marlar Engineering Company, Inc. has been assigned to Halff Associates Inc., which now will be known as Halff Associates, Inc. d/b/a Halff + Marlar; and

WHEREAS, Mike Marlar, the President of the assigned Marlar Engineering Company, Inc., shall continue to perform the professional engineering services set forth in the agreements listed in Exhibit A attached hereto.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the Mayor and City Clerk are hereby authorized to amend all current Agreements between the City of North Little Rock and Marlar Engineering Company, Inc. by substituting the name "Halff Associates, Inc. d/b/a Halff + Marlar", the new entity for Marlar Engineering Company, Inc.

SECTION 2: That the amendment to said Agreements shall be reviewed and approved by the North Little Rock City Attorney's Office prior to execution thereof.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval.


