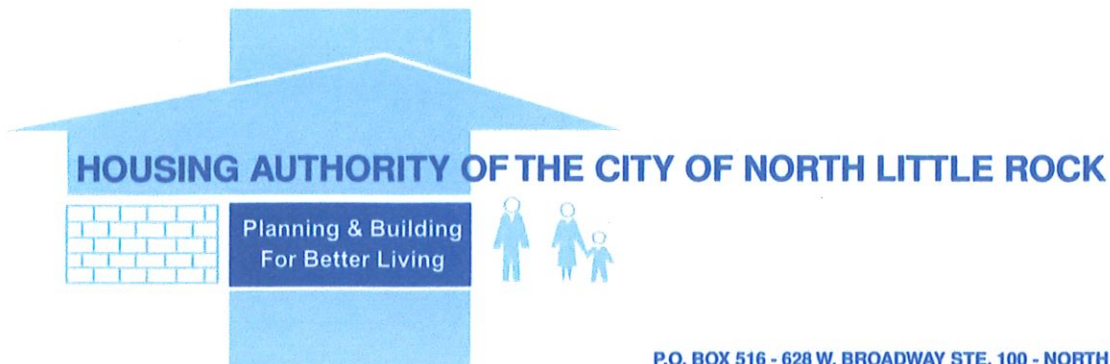

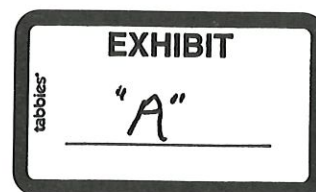
Dear Mayor Smith and City Council Members:
