**A RESOLUTION APPROPRIATING ADDITIONAL FUNDS FOR  
COMPLETION OF THE STORM DRAIN REPLACEMENT  
PROJECT ON GLENMERE ROAD IN THE CITY OF NORTH  
LITTLE ROCK, ARKANSAS; AND FOR OTHER PURPOSES.**

WHEREAS, pursuant to Ordinance No. 8919, adopted June 12, 2017, the City of North Little Rock (the "City") waived formal bidding requirements for a storm drain replacement project on Glenmere Road and appropriated funds in the amount of \$24,590.20 from the Street Department Funds; and

WHEREAS, thereafter it was discovered that the damage to the storm drain was much more severe than originally thought, and Ordinance No. 8925 was adopted on July 10, 2017 waiving formal bidding for additional work on the project and appropriating an additional \$75,000.00 (\$25,000 from Ward I Drainage Funds and \$50,000.00 from Street Department Funds); and

WHEREAS, when excavating began once again on the project area, it was ascertained that not only did more drainage pipe have to be excavated and replaced, but also two (2) 5' x 12' Sanitary Sewer Service Concrete Junction Boxes must be replaced at a cost of \$13,000.00 (\$6,500.00 each); and

WHEREAS, the City Engineer has advised that extensive excavation has been necessary, including additional expenses in replacement of drainage pipe and the two sewer junction boxes, at an additional cost amount of \$48,647.73; and

WHEREAS, the North Little Rock Wastewater Utility has agreed to contribute \$13,000 toward replacement of the junction boxes, leaving an additional amount needed in the amount of \$35,647.73 which has been authorized and may be paid from Ward I Drainage Funds.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That an additional \$48,647.73 is hereby approved for completion of the storm drain replacement project in the 4200 Block of Glenmere Road in the City of North Little Rock.

SECTION 2: That the sum of \$13,000.00 will be paid by the North Little Rock Wastewater Utility, and the balance of \$35,647.73 is hereby appropriated from Ward I Drainage Funds.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval.
