**A RESOLUTION AMENDING RESOLUTION NO. 9568 (2019 BUDGET)
TO AMEND THE FY19 BUDGET FOR FLOOD RELATED EXPENSES;
APPROPRIATING FUNDS; AND FOR OTHER PURPOSES.**

WHEREAS, through its adoption of Resolution No. 9568 on December 10, 2018 (as amended thereafter by Resolution Nos. 9624, 9659, 9675, 9679, 9705, and 9710), the North Little Rock City Council approved the budget for the City of North Little Rock, Arkansas (the "City") for the fiscal year 2019; and

WHEREAS, the City of North Little Rock experienced severe flooding beginning on or about May 27, 2019, resulting in significant damage to publicly owned property; and

WHEREAS, the North Little Rock City Council ("City Council") adopted Resolution No. 9705, which created the Federal Emergency Management Agency ("FEMA") Flood Account, from which all flood related expenditures should be charged in order to facilitate property accounting of flood expenses for the purposes of reimbursement from FEMA; and

WHEREAS, funds in the FEMA Flood Account have run low, and it is in the City's best interests to appropriate an additional \$500,000.00 from the General Fund into the FEMA Flood Account.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the 2019 Budget for the fiscal year 2019 is hereby amended to appropriate an additional Five Hundred Thousand & 00/100 Dollars (\$500,000.00) from the General Fund to Account No. 01-024-52350 - FEMA Flood Expenses - to the Public Works FY2019 budget for payment of flood related expenses.

SECTION 2: That all resolutions or parts of resolutions in conflict herewith are repealed to the extent of the conflict.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval.
