City Clerk Diane Whitbey, Deputy City/Enforcement Officer Shannon Carroll, and City Attorney Amy Fields were also present.

The prayer and pledge of allegiance were led by Council Member Witcher.

On the motion of Council Member Witcher and seconded by Council Member Hight and by consent of all members present, the minutes from the North Little Rock City Council meeting held on Monday, August 27, 2018, were approved, accepted and filed as prepared by the City Clerk (6/0).
