## RESOLUTION NO.

A RESOLUTION AUTHORIZING THE NORTH LITTLE ROCK PARKS AND RECREATION DIRECTOR TO EXECUTE A CUSTOMS POWER OF ATTORNEY WITH THE GILSCOT-GUIDROZ INTERNATIONAL COMPANY, INC. TO ALLOW FOR THE IMPORT OF PLAYGROUND EQUIPMENT FOR THE ONE HEART PLAYGROUND; AND FOR OTHER PURPOSES.

WHEREAS, Inclusive Play is a Scotland based company that manufactures specialized playground equipment for children of all abilities; and

WHEREAS, the North Little Rock Parks and Recreation Department ("Parks and Recreation") has purchased a platform wheelchair swing for the One Heart playground from Inclusive Play, and must use a customs broker due to the swing's import into the United States from Scotland; and

WHEREAS, Gilscot-Guidroz International Company, Inc. ("Gilscot-Guildroz") has been recommended to Parks and Recreation by Inclusive Play as a reliable customs broker; and

WHEREAS, it is in the City of North Little Rock's (the "City") best interest to allow the director of Parks and Recreation to enter into an agreement with Gilscot-Guidroz to allow them to act as the City's customs broker.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the Parks and Recreation Director is hereby authorized to a execute Customs Power of Attorney Agreement (substantially similar to Exhibit A attached hereto) with the Gilscot-Guidroz International Company, Inc to facilitate the import of a platform wheelchair swing from Inclusive Play for the One Heart playground.

SECTION 2: That all documents concerning the granting of any customs power of attorney shall be approved by the City Attorney.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval.
