The Balance Sheet and Income Statement were presented next. Mr. Major mentioned that the income for the hotels was on target through September. Alderman Hight made a motion to accept the Balance Sheet and Income Statement as presented. Mr. Roy seconded the motion and it passed unanimously. Mr. Major then presented the 2014 Hotel Tax Report in descending order by collections which show the top five hotels as being the Wyndham Riverfront, Hilton Garden Inn, Courtyard NLR, Residence Inn and Holiday Inn Express. Next the 2014 Restaurant Tax report was presented by Mr. Major. The 2014 Restaurant Tax Report revealed that the top 5 restaurants in descending order to be Golden Corral, Wyndham Hotel/Benihana's, Chick Fil-A, Olive Garden and Texas Roadhouse. Alderman Hight made a motion to accept the financial reports as presented. Mr. Roy seconded the motion and it passed unanimously.

Mr. Roy made a motion to accept the Ongoing Delinquent Tax Report as presented. Mr. Best seconded the motion and it passed unanimously.

The next Commission item was to discuss the purchase of a new company vehicle. The current vehicle has 9 safety recalls on it and is not safe to be driven any time soon. The only response to the bid was presented and Alderman Hight made a motion to accept the proposal. Mr. Best seconded the motion and it passed unanimously.

The next order of business was the Director's Report for the third quarter of 2014. Mr. Major reviewed the Visitor Information Center Report. He explained that the numbers for the Visitor Information Center were up for the 3<sup>rd</sup> Quarter. July was up by 19%, August was up by 1% and September had an increase of 3%. The top five leading states of origin were Arkansas, Oklahoma, Louisiana, Texas and Tennessee. The total of 199 foreign visitors from 21 countries including: Argentina, Australia, Belgium, Bermuda, Canada, Costa Rica, England, Finland, France, Germany, Iran, Ireland, Italy, Japan, New Zealand, Netherlands, Spain, Sweden and Switzerland. The Downtown Riverside RV Park had a total income of \$193,717.00 with a total of 3,417 reservations. Mr. Major discussed the figures from the Arkansas Inland Maritime Museum to be doing very well with a year to date income of \$294,611.00 with 12,589 visitors. Alderman Hight made a motion to accept the Director's Report as presented and Mr. Roy seconded it. The motion passed unanimously.

The next A & P Commission meeting will be held on Tuesday, January 20, 2015 at 3:30p.m. at a location to be determined. With no other business to discuss, the meeting was adjourned at 4:36 p.m.
